Clauses:

This document offers a guarantee of 30 years for models Alicante-12, TB-12, TB-4, C-50.21 Celler, Step Celler 50/45, C-45.20, C-40.19, C-40.15, C-25.12 and Escama, in accordance with norm EN 1304 in force on the manufacturing date, under the following conditions:

- The manufacturer's instructions and the technical code of the country have been complied with and particularly that referring to the ventilation of the deck.
- All tiles and accessories installed have been manufactured by Tejas Borja and are those recommended by this manufacturer for a proper construction of the deck. Any painted, varnished, hydrofuged tiles subjected to any treatment not carried out by Tejas Borja, shall not be covered by this guarantee.
- Excluded from this guarantee:
 - Water leaks due a faulty laying of the tiles are excluded from this certification.
 - Any damage caused by movement, distortion, cracking or settling of the walls or foundation of the building.
 - Any damage caused by the impact of objects, fire, earthquakes, flooding... or any force majeure.
- This guarantee does not apply in case of defects which are visible on the delivery of the tiles such as differences in the tonality or damages caused by the transportation. Additionally, due to the nature of the tiles as well as the possible effects of the surrounding environment,
- Tejas Borja shall not be responsible for changes in tonality or ageing of the tiles.
- The guarantee entails the free disposal of the material delivered under conditions EXW (Ex work). Neither the costs arisen from the removal of the defective tiles or transportation or installation of new ones, nor indirect damages which may have been caused are included.
- This guarantee shall come into force on the date of the invoice when the goods are delivered. In order for this guarantee to be enforced it shall be necessary to present this certification together with the delivery notes and the paid invoices on the due date of the delivered material.
- Deadline for completing the certificate will be 1 year maximum from the date of the invoice.
- Any problem in the roof, must be reported. The staff of Tejas Borja shall establish a claim management process accordingly.
- Any legal action that may arise from this document shall be settled in the courts of Valencia (Spain)

This certification shall not be valid unless it bears the signature and stamp of Tejas Borja S.A.U.
